APRIL 1, 2018

The Governing Body of the City of Sublette, Kansas met in regular session at City Hall at 7:00 p.m. with Mayor Lawrence Hoerman presiding and the following members of the City Council present: James Barber, Tom Stoppel, Leon Birney, Dylan Shotton and Sterling Hall. Also present were City Attorney Lynn Koehn, City Superintendent Daylen Elsey, Undersheriff Denton Unruh, Fire Chief Rusty Sherwood and City Clerk Jeannie Trigg.

The minutes of the last regular meeting were approved as distributed with a motion by Councilmember Shotton, seconded by Councilmember Birney. The motion carried 5-0.

Undersheriff Denton Unruh was present to give the monthly law enforcement report. He discussed dogs and happenings within the City.

Fire Chief Rusty Sherwood was present to give the monthly fire report. He updated the Council on wiring and lighting at firehouse. He informed the Council about truck problems. He informed the Council that the fire department voted 14-4 in favor to add Bobbie Campbell as a new fireman to the department. A motion was made by Councilmember Birney, seconded by Councilmember Stoppel to add Bobbie Campbell to the fire department. The motion carried 5-0.

City Clerk Trigg reported to the Council that there are no applications for Pool Manager.

Superintendent Elsey gave the monthly water report. He discussed plaster repairs that are needed on the pool. He discussed wells.

Attorney Koehn discussed Ordinances to be considered for adoption. The Council discussed the propane Ordinance. A motion was made by Councilmember Hall, seconded by Councilmember Birney to pass Ordinance No. 411-A, to replace Ordinance No. 411. AN ORDINANCE REGULATING PROPANE TANKS WITHIN THE CITY OF SUBLETTE, KANSAS. The motion carried 3-2, with Councilmembers Shotton and Stoppel voting no. A motion was made by Councilmember Birney, seconded by Councilmember Shotton to pass Ordinance No. 431: AN ORDINANCE AMENDING PRIOR ORDINANCES REGARDING THE APPOINTMENT OF CERTAIN OFFICERS IN THE CITY OF SUBLETTE, KANSAS. The motion carried 5-0.

The Council discussed domestic water wells. A motion was made by Councilmember Barber, seconded by Councilmember Birney to pass Ordinance No. 432: AN

ORDINANCE SETTING RESTRICTIONS AND PROHIBITIONS TO NON-PUBLIC DOMESTIC WATER WELLS IN THE CITY OF SUBLETTE, KANSAS. The motion carried 5-0.

Councilmember Stoppel discussed an Insurance adjustment on the water tower to put the value at \$772,000.00 instead of \$619,000.00 and to put it in the umbrella package. A motion was made by Councilmember Stoppel, seconded by Councilmember Barber to make the water tower adjustment and put all insurance under an umbrella package. The motion carried 5-0.

Mayor Hoerman discussed with the Council the need to review and pass the Code Book of the City of Sublette that was compiled by Citycode Financial.

A motion was made by Councilmember Shotton seconded by Councilmember Barber to approve and allow payment of the bills as distributed. The motion carried 5-0.

Councilmember Stoppel made a motion to adjourn, seconded by Councilmember Barber. The motion carried 5-0.
