SEPTEMBER 4, 2018

The Governing Body of the City of Sublette, Kansas met in regular session at City Hall at 7:00 p.m. with Mayor Lawrence Hoerman presiding and the following members of the City Council present: James Barber, Leon Birney, Tom Stoppel, Dylan Shotton and Sterling Hall. Also present were City Superintendent Daylen Elsey, Sheriff Troy Briggs, Fire Chief Rusty Sherwood and City Clerk Jeannie Trigg. Visitors were Ashton Koehn and Laynee Koehn

The minutes of the last regular meeting were approved as distributed with a motion by Councilmember Hall, seconded by Councilmember Shotton. The motion carried 5-0.

Sheriff Troy Briggs was present to give the monthly law enforcement report. He reported on doings and happenings within the City. He discussed dog nuisances.

Fire Chief Rusty Sherwood was present to give the monthly fire report. He discussed new Firemen radios. A motion was made by Councilmember Hall, seconded by Councilmember Birney to rescind the motion made in June of 2017 to buy two Motorola radios at the cost of \$2,142.43 each. The motion carried 5-0. A motion was made by Councilmember Birney, seconded by Councilmember Stoppel to purchase two 900 Motorola radios with four shoulder Bluetooth microphone sets, not to exceed \$5,000.00. The motion carried 5-0. A motion was made by Councilmember Birney, seconded by Councilmember Stoppel to purchase one set of bunker gear, not to exceed \$2,000.00. The motion carried 5-0.

City Clerk Jeannie Trigg discussed with the Council computer issues. She presented a bid from Palace Computer Center for two new I5 Tower Workstations, with Microsoft Windows 10 Pro and labor to transfer and setup at the cost of \$2,743.12. A motion was made by Councilmember Barber, seconded by Councilmember Birney to purchase the two I5 stations, windows 10 Pro and labor for transfer and setup from Palace Computer at the cost of \$2,743.12. The motion carried 5-0.

Superintendent Elsey gave the monthly water report. He discussed replacing the water line from Carson Ave on Derby to the Carson/Chouteau alley west to Cox Street. A motion was made by Councilmember Stoppel, seconded by Councilmember Hall to replace the water line not to exceed \$13,000.00. The motion carried 5-0. He discussed Brad Menzie wanting to purchase City water at his property on West Lalande Ave. A motion was made by Councilmember Barber, seconded by Councilmember Shotton to sell Brad Menzie and American Implement City water. The motion carried 4-1, with Councilmember Birney abstaining and Councilmember Hall voting no. He also discussed revising a section from water Ordinance No. 361. Attorney Koehn will amend the Ordinance and present at next meeting.

The Council discussed cleanup. A motion was made by Councilmember Hall, seconded by Councilmember Shotton to enforce Ordinance No. 423 by having Law Enforcement issue a nuisance citation to Andy Cauthon on 505, 505 ½ and 507 W. Carson Avenue. The motion carried 5-0.

The Council discussed the pool repair. Superintendent Elsey reported that Pools Plus will be here in late October to look at needed repairs.

The Council discussed water and trash rates. Clerk Trigg will acquire water and sewer rate data from the Kansas Rural Water Association.

Attorney Koehn recommended that the Council adopt the 2018 editions published by the League of Kansas Municipalities for Standard Traffic and Uniform Public Offense Code for the Cities in Kansas with changes and exceptions to revise the ordinances. Koehn presented Ordinance No. 433: AN ORDINANCE FOR THE CITY OF SUBLETTE, KANSAS ADOPTING THE “STANDARD TRAFFIC ORDINANCE FOR CITIES IN KANSAS” WHICH PROVIDES FOR TRAFFIC REGULATIONS, DEFINING AND PROVIDING PENALTIES FOR THE VIOLATIONS THEREFORE; AND THEN RE-ENACTING AND RETAINING OF CERTAIN PREVIOUSLY PASSED TRAFFIC ORDINANCES. A motion was made by Councilmember Barber, seconded by Councilmember Stoppel, to adopt Ordinance No. 433. The motion carried 5-0.

Koehn presented Ordinance No. 434: AN ORDINANCE FOR THE CITY OF SUBLETTE, KANSAS ADOPTING “THE UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES”, AND ANY AMENDMENTS THERETO, WITH CERTAIN EXCEPTIONS AND ADDITIONS; PROVIDING FOR AND REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE CITY LIMITS; AND REPEALING ANY ORDINANCES INCONSISTENT WITH THE PROVISIONS OF THIS ORDINANCE WITH CERTAIN EXCEPTIONS NOTED. A motion was made by Councilmember Stoppel, seconded by Councilmember Barber, to adopt Ordinance No. 434. The motion carried 5-0.

Councilmember Hall excused himself from the meeting at 9:05 p.m.

A motion was made by Councilmember Shotton seconded by Councilmember Birney to approve and allow payment of the bills as distributed. The motion carried 4-0.

Councilmember Barber made a motion to adjourn at 9:13 p.m., seconded by Councilmember Birney. The motion carried 4-0.
