The Governing Body of the City of Sublette, Kansas met in regular session at 7:00 p.m. with Mayor Lawrence Hoerman presiding and the following members of the City Council present: Leon Birney, James Barber, Tom Stoppel, Dylan Shotton and Jason Vaughn. Also present were City Superintendent Daylen Elsey, Sheriff Troy Briggs, Fire Chief Rusty Sherwood and City Clerk Jeannie Trigg. Visitors were Gerald Stoppel, LeRoy Mast, Aggie Berg and Parker Kelling.

The minutes of the last regular meeting were approved as distributed with a motion made by Councilmember Stoppel, seconded by Councilmember Vaughn. The motion carried 5-0.

LeRoy Mast and Gerald Stoppel were present for rezoning property located at NE/4 36-T29S-R33W. The owner has requested rezoning of the property from “(AG) Agricultural to (C-2) Commercial”. The legal description of the subject property is: A tract of land located in the Northeast Quarter (NE/4) of Section Thirty-six (36), Township Twenty-nine (29) South, Range Thirty-three (33) West of the 6th P.M., Haskell County, Kansas, exact description to be determined by actual survey. 10 acres of south side of NE ½ of Sec. 36-29-33 Haskell Co. approximately 1,300 ft. East & West and 335 ft. North & South. A motion was made by Councilmember Vaughn, seconded by Councilmember Birney to approve the rezoning application of Mast Trucking. The motion carried 5-0.

Fire Chief Rusty Sherwood was present to give the monthly fire report. He informed the Council that the fire department voted to put Dalton Brooks on the fire department. A motion was made by Councilmember Birney, seconded by Councilmember Shotton to approve Dalton Brooks to the fire department. The motion carried 5-0. He discussed fire runs and a fire truck.

Sheriff Troy Briggs was present to give the monthly law enforcement report. He reported on traffic and the highway project.

Superintendent Elsey gave the monthly water report. He reported on water wells. He Discussed nuisance clean up at 505 W. Carson. The Council recommended that a citation be issued to the property owner.

Chamber asked for permission to block off Inman Street for Fall Fest on October 28 from 5:00 to 8:00 p.m.; from Highway 56 to Courthouse Avenue/Fern Avenue and side streets entering Inman Street at Carson Avenue and Becknell Avenue. A motion was made by Councilmember Barber, seconded by Councilmember Birney to approve the blocking of the streets for Fall Fest. The motion carried 5-0.

The Council discussed City Clerk applications. A committee will set up interviews for this month and make a recommendation to the Council at the October meeting.

A motion was made by Councilmember Birney, seconded by Councilmember Barber to approve and allow payment of the bills as distributed. The motion carried 5-0.

A motion was made by Councilmember Barber, seconded by Councilmember Birney to go into executive session to include Clerk Trigg and Superintendent Elsey at 8:30 p.m. until 8:45 p.m. to discuss personnel matters of non-elected personnel. The motion carried 5-0. The Council came out of executive session at 8:45 p.m. No action was taken.

Councilmember Barber made a motion to adjourn at 9:18 p.m., seconded by Councilmember Stoppel. The motion carried 5-0.
