The Governing Body of the City of Sublette, Kansas met in regular session at City Hall at 7:00 p.m. with Mayor Lawrence Hoerman presiding and the following members of the City Council present: James Barber, Tom Stoppel, Leon Birney, Dylan Shotton arrived at 7:02 and Sterling Hall. Also present were City Attorney Lynn Koehn, City Superintendent Daylen Elsey, Undersheriff Denton Unruh, Fire Chief Rusty Sherwood and City Clerk Jeannie Trigg. Visitors were Louie Herman, Scott Woods, Deputy Alex Louderback and Deputy Conner Cook.

The minutes of the last regular meeting were approved as distributed with a motion by Councilmember Barber, seconded by Councilmember Stoppel. The motion carried 4-0.

Superintendent Elsey opened Notice of Sale sealed bids for auction items:

A motion was made by Councilmember Barber, seconded by Councilmember Birney to accept all the bids except the \$5 for the 5.9 Valve Engine. The motion carried 5-0, with Councilmember Hall abstaining.

Louie Herman, Regional Manager for Crop Production Service, and Scott Woods were present to discuss with the Council the possibility of getting hooked up to City water.

The Council discussed water sales outside the city limits. A motion was made by Councilmember Hall, seconded by Councilmember Barber to not allow sale of bulk water to outside sources outside the city limits. The motion failed 2-3, with Councilmember Birney, Shotton and Stoppel voting no. A motion was made by Councilmember Birney, seconded by Councilmember Stoppel to amended Ordinance No. 361, Section 10, for loading dock bulk water; charge shall be \$500.00 per 1,000 gallons. The motion carried 4-1, with Councilmember Hall voting no.

Undersheriff Denton Unruh was present to give the monthly law enforcement report. He introduced the new deputies Connor Cook and Alex Louderback.

Fire Chief Rusty Sherwood was present to give the monthly fire report. He discussed fire runs. He discussed allowing fireworks in the City limits, no ban was put on fireworks at this time. He discussed communication with Haskell Township concerning a new fire truck.

Superintendent Elsey gave the monthly water report. He discussed with the Council complaints about dogs, noise and number of dogs per household. Superintendent Elsey will notify the people with complaints, to file a complaint as addressed by the Ordinance. The Council will discuss the issue at next meeting.

The Council discussed adding a fee for drilling a domestic water well to Ordinance No. 432. A motion was made by Councilmember Birney, seconded by Councilmember Barber to add a \$10,000.00 registration fee for drilling of a domestic well to Ordinance No. 432. The motion carried 5-0. Attorney Koehn will amend the Ordinance.

Mayor Hoerman reminded Council about the Budget Work session June 25th at 5:30 p.m.

The Council discussed bindweeds issue in the City.

The Council discussed water rights.

A motion was made by Councilmember Stoppel seconded by Councilmember Birney to approve and allow payment of the bills as distributed. The motion carried 5-0.

Councilmember Barber made a motion to adjourn at 10:01 p.m., seconded by Councilmember Stoppel. The motion carried 5-0.
