The Governing Body of the City of Sublette, Kansas met in regular session at City Hall at 7:00 p.m. with Mayor Lawrence Hoerman presiding and the following members of the City Council present: James Barber, Tom Stoppel, Leon Birney, Dylan Shotton and Sterling Hall. Also present were City Attorney Lynn Koehn, City Superintendent Daylen Elsey, Undersheriff Denton Unruh, Fire Chief Rusty Sherwood and City Clerk Jeannie Trigg.

The minutes of the last regular meeting and special meetings were approved as distributed with a motion by Councilmember Birney, seconded by Councilmember Shotton. The motion carried 5-0.

Undersheriff Denton Unruh was present to give the monthly law enforcement report. He informed the Council they hired a new deputy, Connor Cook.

Fire Chief Rusty Sherwood was present to give the monthly fire report. He discussed fire runs and new fire gear.

City Clerk Trigg presented pool manager and lifeguard applications. A motion was made by Councilmember Stoppel, seconded by Councilmember Hall to rehire Whitney Hampton as the Pool Manager with a raise from \$14.50 an hour to \$15.00 an hour. She will be responsible for concessions, cleaning, swim lessons, daily operations and lifeguards. A motion was made by Councilmember Shotton, seconded by Councilmember Birney to

rehire Quinnton Gonzales, Marcedies Vogts, Noah Horinek and Jessica Schield and new hires Tea Stoppel, Riley Frank, Reagan Frank and Malachi Fabian. The motion to include Quinton Gonzales and Marcedies Vogts as head lifeguard at the rate of \$9.00 an hour, a \$.25 an hour raise for returning guards; Noah Horinek at the rate of \$7.75 an hour, Jessica Schield at the rate of \$7.50 an hour, and new lifeguard hires Tea Stoppel, Riley Frank, Reagan Frank and Malachi Fabian at the rate of \$7.25 an hour. The motion carried 5-0. A motion was made by Councilmember Shotton, seconded by Councilmember Hall to buy one swimsuit per lifeguard to be worn while on duty. The motion carried 5-0. Whitney will do the lifeguard training for the guards; City will pay the Red Cross certification fee.

Superintendent Elsey gave the monthly water report. He discussed plaster repairs that are needed on the pool. He discussed mowing and maintenance of the city parks. A motion was made by Councilmember Barber, seconded by Councilmember Birney to hire T & T Lawn Care to mow city parks from April 1st to September 15th. The motion carried 5-0. A motion was made Councilmember Barber, seconded by Councilmember Shotton to hire T and T Landscaping to continue the chemical program for the city parks. The motion carried 5-0. The Council discussed city street sealing. A motion was made by Councilmember Barber, seconded by Councilmember Hall to approve the expenditure of \$80,000.00 for street sealing. The motion carried 4-1, with Councilmember Stoppel voting no.

The Council discussed water rights.

The Council discussed adding a \$500.00 registration fee for domestic water wells to Ordinance 432. Attorney Koehn will amend the Ordinance, adding a registration fee.

Mayor Hoerman reminded Council about the Budget Work session June 25th at 5:30 p.m.

The Council discussed the City Code book update.

A motion was made by Councilmember Shotton seconded by Councilmember Birney to approve and allow payment of the bills as distributed. The motion carried 5-0.

Councilmember Stoppel made a motion to adjourn at 9:34 p.m., seconded by Councilmember Barber. The motion carried 5-0.
