SEPTEMBER 5, 2017

The Governing Body of the City of Sublette, Kansas met in regular session at City Hall at 7:00 p.m. with Mayor Jery Bailey presiding and the following members of the City Council present: Lawrence Hoerman, James Barber, Leon Birney, Tom Stoppel and Dylan Shotton. Also present were City Superintendent Daylen Elsey, Deputy Victor Mora, Assistant Fire Chief John Hall and City Clerk Jeannie Trigg. Visitor was John Cauthon

Mayor Bailey opened the meeting with a prayer.

The minutes of the last regular meeting and special meeting were approved as distributed with a motion by Councilmember Stoppel, seconded by Councilmember Barber. The motion carried 5-0.

John Cauthon was present to discuss with the Council his property clean up.

Deputy Victor Mora gave the monthly law enforcement report for the City.

Assistant Fire Chief John Hall was present to report on fire runs. He informed the Council that they had ordered gloves and are waiting on a sales representative to come measure for bunker gear. He discussed truck repairs.

Superintendent Elsey gave the monthly water report. He discussed the water tower monitoring system. A motion was made by Councilmember Birney, seconded by Councilmember Barber to approve the monitor system from Presley Solutions at the cost of \$1,860.00. The motion carried 5-0. He gave a bid from Spray Foam Solutions, LLC to insulate the City Shop walls. A motion was made by Councilmember Barber, seconded by Councilmember Shotton to hire Spray Foam Solutions to spray 2" depth insulation on walls, with white paint applied over the foam at the cost of \$6686.25. The motion carried 5-0. He also gave bids on heaters to heat the shop. A motion was made by Councilmember Stoppel, seconded by Councilmember Barber to buy two 250,000 btu heaters at the cost of \$1672.00 each having the City Maintenance install. The motion carried 4-1, with Councilmember Hoerman voting no. He discussed with the Council moving the alley on North Inman. A motion was made by Councilmember Hoerman, seconded by Councilmember Birney to hire Stoppel Dirt at the cost of \$1000.00 to move the alley on the West side of North Inman. The motion carried 5-0. He informed the Council on the status of Dennis Street ditches. He discussed a new water line for South Inman for the Morris triplex construction. A motion was made by Councilmember Shotton, seconded by Councilmember Hoerman to install a new 6" water line in the City right-of-way on the East side of Inman Street, to serve the new construction and improve the water infrastructure in that area.

City Clerk Trigg presented to the Council the 2017 editions published by the League of Kansas Municipalities for Standard Traffic and Uniform Public Offense Code for the Cities in Kansas with changes and exceptions to revise the ordinances: Ordinance No. 429: AN ORDINANCE FOR THE CITY OF SUBLETTE, KANSAS ADOPTING THE "STANDARD TRAFFIC ORDINANCE FOR CITIES IN KANSAS" WHICH PROVIDES FOR TRAFFIC REGULATIONS, DEFINING AND PROVIDING PENALTIES FOR THE VIOLATIONS THEREFORE; AND THEN RE-ENACTING AND RETAINING OF CERTAIN PREVIOUSLY PASSED TRAFFIC ORDINANCES. A motion was made by Councilmember Hoerman, seconded by Councilmember Shotton, to adopt Ordinance No. 429. The motion carried 5-0.

Trigg presented Ordinance No. 430: AN ORDINANCE FOR THE CITY OF SUBLETTE, KANSAS ADOPTING "THE UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES", AND ANY AMENDMENTS THERETO, WITH CERTAIN EXCEPTIONS AND ADDITIONS; PROVIDING FOR AND REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE CITY LIMITS; AND REPEALING ANY ORDINANCES INCONSISENT WITH THE PROVISIONS OF THIS ORDINANCE WITH CERTAIN EXCEPTIONS NOTED. A motion was made by Councilmember Barber, seconded by Councilmember Stoppel, to adopt Ordinance No. 430. The motion carried 5-0.

A motion was made by Councilmember Birney, seconded by Councilmember Shotton to approve and allow payment of the bills as distributed. The motion carried 5-0.

Councilmember Barber made a motion to adjourn, seconded by Councilmember Stoppel. The motion carried 5-0.
