ORDINANCE NO. 422

AN ORDINANCE AMENDING SECTION 9 OF ORDINANCE 361; REPEALING ORDINANCE 382; THEREBY ADJUSTING THE WATER RATE AS PREVIOUSLY SET FOR THE CITY OF SUBLETTE, KANSAS.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SUBLETTE, KANSAS.

SECTION 1. Section 9 of Ordinance 361 is hereby amended as follows:

**“Section 9. IN THE CITY WATER RATE.** The charge to be made and collected by the City of Sublette, Kansas, for all water produced, distributed, sold and used by all persons within the said City of Sublette, shall be calculated and charged at the following rates of consumption:

- a.) A minimum charge of \$10.00 for the first 2,000 gallons, or any portion thereof per month; per dwelling unit, business, or taxing entity.
- b.) \$1.25 per 1,000 gallons in excess of the minimum allowance of 2,000 gallons and up to 5,000 gallons of usage per month; per dwelling unit, business, or taxing entity.
- c.) \$1.50 per 1,000 gallons for all water usage over 5,000 gallons per month and up to 10,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- d.) \$1.75 per 1,000 gallons for all water usage over 10,000 gallons per month and up to 25,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- e.) \$2.00 per 1,000 gallons for all water usage over 25,000 gallons per month and up to 50,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- f.) \$3.00 per 1,000 gallons for all water usage over 50,000 gallons per month and up to 100,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- g.) \$4.00 per 1,000 gallons for all water usage over 100,000 gallons per month; per dwelling unit, business, or taxing entity.

OUT OF CITY WATER RATE. The charge to be made and collected by the City of Sublette, Kansas, for all water produced, distributed, sold and used by all persons outside

of the city limits of Sublette, Kansas shall be calculated and charged at the following rates of consumption:

- a.) A flat set rate of \$20.00 per month per dwelling unit, business, or taxing entity hooked up to a City water meter regardless of amount of water usage.
- b.) \$2.50 per 1,000 gallons and up to 5,000 gallons per month; per dwelling unit, business, or taxing entity.
- c.) \$3.00 per 1,000 gallons for all water usage over 5,000 gallons per month and up to 10,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- d.) \$3.50 per 1,000 gallons for all water usage over 10,000 gallons per month and up to 25,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- e.) \$4.00 per 1,000 gallons for all water usage over 25,000 gallons per month and up to 50,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- f.) \$6.00 per 1,000 gallons for all water usage over 50,000 gallons per month and up to 100,000 gallons per usage per month; per dwelling unit, business, or taxing entity.
- g.) \$8.00 per 1,000 gallons for all water usage over 100,000 gallons per month; per dwelling unit, business, or taxing entity.


Section 2. CONFLICTING ORDINANCES/SEVERABILITY. Ordinances and parts of ordinances in conflict with this ordinance are hereby amended and repealed. Specifically Ordinance 382 is repealed. That in the event any part or portion of this ordinance is found to be invalid, the invalidity of such shall not affect the other provisions or applications of the ordinance which can be given without the invalid part or portions.

Section 3. PUBLICATION. This ordinance shall become effective on January 1<sup>st</sup>, 2016 after the publication of the same in the official city newspaper.
